John Marsala made professional bowling history on Tuesday night at the PBA50 Bud Moore Classic. When he stepped up on lane 14 inside Bud Moore Lanes and flushed his seventh strike of the championship match in the foundation frame against Brad Angelo, he felt relief and a lot of emotion.

"Tears were coming and that made it really hard to throw the first one in the tenth," he said after closing out Angelo in the title match. "It made me feel like I belong out here and I can compete with the Hall of Famers."

The lefty was in control of the entire match starting off with a spare followed by six strikes in a row on his way to the 255-226 victory. In the fifth frame, Marsala got a brief scare when the seven and 10-pin stood for a moment and then almost simultaneously fell to the right, as part of Marsala's important string of strikes.

"I was a little fast on that shot and when that fell for me, I had a bunch of momentum," he said of that key moment in the match. "My Phase II, it read the right part of the lane and I

knew this was the ball to

The stepladder finals were held on two lanes inside the home of tournament sponsor, Bill Moore. Parker Bohn III. Amleto Monacelli and Walter Ray Williams Jr. were sitting just off to the side of the lanes watching this unique match along with specta-

And so it is with Pete Weber, the on again, off again superhero of professional bowling, who won again for the second consecutive week at the Granville Financial Open at Sandhills Bowling Center in Aberdeen. North Carolina, the latest stop on the PBA50 Senior Tour.

The list of accomplishments for Pete Weber on Angelo, who led the the Professional Bowlers Association (PBA) Tour are too numerous to mention, including 37 titles on the regular tour and eleven on the senior circuit. But the statistic that stands out for me is his domination of the major events in both the regular and senior divisions of the PBA. No other bowler, with the possible exception of Don Carter, has so dominated the men's majors in any era of bowling history.

My first meeting with a young Pete Weber took place during AMF's negotiations to purchase Dick Weber Lanes, the Florissant. Missouri home of Pete's famous father. The usual procedure that AMF employed was to have me visit a potential acquisition for a week to get a feel for the business, the clientele, and to verify the league bowling information that had been sent by visual observation every evening.

Pete, who was already a PBA champion with a couple of titles under his belt when we first met, was an

KYLE TROUP AND SAM COOLEY ADVA KIA PBA PLAYOFFS CHAMPIONSHIP MATCH

MILFORD, Conn.—Top seed Kyle Troup and No. 11 seed Sam Cooley will face off for the 2021 Kia PBA Playoffs Championship tomorrow on FOX Broadcast Channel. Both players swept their opponents, 2-0, in a race-to-two-points format in which each game is worth one point. Troup defeated No. 4 seed François Lavoie and Cooley eliminated No. 15 seed Cristian Azcona.

Lavoie, who defeated Troup in the final match of the Guaranteed Rate PBA Super Slam in April, built an early lead in the first game with the front six, but an open in the ninth frame gave Troup a chance.

"I definitely wanted to get a little revenge on him," said Troup of avenging his loss in the Super Slam. "When he gave me that chance in the first game, I had to commit to the ball change in the 10th. It worked out well and I felt very confident moving forward. It's very nice knowing I have the Rubicon and the UC2 that work well every time we bowl on this pair. That gives me a lot of confidence."

With the win over Lavoie, Troup will eclipse Walter Ray Williams Jr.'s singleseason earnings record of \$419,700, accomplished during the 2002-03 season. Troup currently sits at \$369,200 this season and will add either \$100,000 for a Kia PBA Playoffs win or \$60,000 for a runner-up finish.

"I'm pretty speechless as far as that goes," said Troup. "To beat another major champion in the round of four and then to beat a record holder, the greatest of all time, is an honor."

Cooley, who eliminated Jesper Svensson in the Round of 16 and Tom Daugherty in the quarterfinals, both via tie-breaking roll-offs, didn't need a roll-off in the semifinals, winning both games over Azcona. After a 264-243 win in game one, the lanes appeared to get tricky for both players in game two.

"In the third frame when I six-pinned, I hit up on it a little bit too much and it instantly hooked," said Cooley. "I made a move the next time I got there and the ball never hooked. It never hit the strip where we'd broken it down. I moved back to where I was and threw it a little bit firmer."

Cooley clinched his trip to the championship match with a strike in the 10th

"I was able to get away with one the next time I was on the right lane," said Cooley. "I tripped the 7-9 back, but then I pured it in the 10th to seal it. It's a pretty good feeling going into tomorrow."

AZCONA, COOLEY WIN ROLL-OFFS TO ADVANCE TO KIA PBA PLAYOFFS SEMIFINALS

Cristian Azcona edges EJ Tackett, Sam Cooley knocks out Tom Daugherty

MILFORD, Conn.—No. 15 seed Cristian Azcona and No. 11 seed Sam Cooley both overcame game-one losses to force and win tie-breaking roll-offs and advance to the Kia PBA Playoffs semifinals. Azcona eliminated 10th-seeded EJ Tackett and Cooley upset No. 3 seed Tom Daugherty. Azcona and Cooley will face each other in the semifinals.

In a race-to-two-points format, each game is worth one point. If the players are tied after two games, a ninth-and-10th-frame roll-off decides the winner of the match.

After dropping game one to Tackett, Azcona put up seven strikes in the second game on his way to a 240-214 win to necessitate a roll-off. Azcona began the rolloff with a strike, which Tackett matched. Tackett finished first, striking in the 10th and then leaving a 4-8. Taking just the 4 pin on his spare attempt, Tackett finished with a score of 47, forcing Azcona to strike and get nine pins to win. That's exactly what Azcona did, advancing to the semifinals.

Likewise, Cooley lost the first game to Daugherty but tied the match with a victory in game two. Despite trailing early in the second game, Cooley strung five consecutive strikes in the middle of the game to overtake Daugherty for a 236-218 win.

As the higher seed, Daugherty elected to bowl first in the roll-off, starting with a spare. Cooley posted a score of 37, requiring Daugherty to roll nine, spare, nine to win. Instead, Daugherty left the 2-4-10 split and failed to convert, leaving Cooley with a 37-26 victory and the final spot in the semifinals.

The winner of the PBA Playoffs will receive a PBA Tour title, \$100,000 and an official WWE championship title belt.

missed 9 pin in the sixth. "I was frustrated about the bad break," said Troup of missing the 9 pin. "I flagged it. I had to get myself refocused. Once I did that, I was okay." Troup doubled in the 10th to clinch game three and take a 2-1 lead entering the fourth game.

"I felt like I bowled a fantastic game four," said Troup. "The lanes were just toast. They were ugly." Troup struck on his first shot in the 10th frame of game four, then left an 8-10 split on

his next shot, needing one pin to clinch the victory. Troup took down the 8 pin and immediately hoisted the WWE championship title belt.

"I wanted to pick this belt up, give the Ric Flair 'Wooo,' and bring the belt back home," said Troup. "I know I have a lot of fans back home rooting me on and people around the world. It's so special to get this win."

Perhaps making it more special is Troup's eighth career title ties him with his father, Guppy, who was in attendance for all of Kyle's Playoffs victories, in all-time Guaranteed Rate PBA Tour titles. "I caught up to him," said Kyle Troup, adding, "I'm thinking I'm getting to nine a lot faster than he is."

of a delegate to a pacifist's convention, and that I had no interest in defending my record against one of the greatest bowlers that the world has ever known, we became fast friends in a relationship of mutual admiration that has continued to this day.

During that week I was welcomed into the Weber household and experienced midwestern hospitality on more than one occasion with home cooked meals and a visit to the famous trophy room that housed all of the Weber's bowling

memorabilia. Dick also made it clear to a couple of his sons, Pete and John, that my association with them could be beneficial once the bowling center transaction was complete.

He was right! John became a Bowling Activities Representative for the midwestern region of AMF Bowling Centers, a position that he would hold for a couple of years before deciding to accept a position with the PBA; and Pete became one of the most sought-after professional keglers for exhibitions on the AMF Staff of Champions - second only to his father in popularity.

My fondest memory of Pete's celebrity appearances took place at AMF Anderson Bowl, in Anderson, South Carolina. While Dick Weber was by far the most polished of the AMF staff of bowlers and clinicians, I found myself booking Pete more and more often because of his flamboyant style and tournament performances. In view of the fact that Pete was very comfortable with match play competition, we came up with a doubles competition that he enjoyed, as opposed to the normal bowling clinic format.

Under the unique format that was first introduced by manager Mike O'Barr of Anderson Bowl, the team of Pete Weber and Dave Williams was pitted against many of the top flight bowlers in the area, as well as local television and radio personalities. One team that did not stand out at the time, but that eventually won the competition, was the team of J.D. Hayworth and Mike Seidel of WYFF-TV Channel 4 in nearby Greenville, South Carolina.

You might recognize those names... J.D. Hayworth went on to a successful career in the United States Congress as a representative from Arizona, and for many years hosted a show on Newsmax-TV called Newsmax Prime. Not to be outdone, Mike Seidel has been your voice for extreme weather reports on The Weather Channel for almost 30 years. Now, you might be wondering how this team of amateurs could ever beat the formidable team of Weber & Williams in a match without any handicap?

There's a couple of reasons that Pete and I received a particularly polished pasting at the hands of Hayworth &

Needless to say, the scores rolled were substantially below expectations, but in spite of that embarrassing moment, Pete and I both carried on with a bowling segment that followed the celebrity bowl-off.

And now, after 42 years on the PBA Tour, Pete is calling it guits. However, he will still be around for the PBA50 Senior Tour, and some of the regional events hosted by the PBA. In an emotional interview on *FloBowling* earlier this year, Pete Weber was philosophical and characteristically candid when he stated, "Whether you hated me, or you loved me - you watched, and I love you all." 




